Collision near Dotsero in January 1909 killed scores of people

hen two Denver & Rio Grande Railroad trains collided on the night of Jan. 15, 1909, near the east entrance to Glenwood Canyon, 26 people died, and blame for the wreck quickly fell

upon a Glenwood Springs railroad engineer driving one of the trains.

Three locomotive engines were involved, one pulling a westbound passenger train and two powering an eastbound freight.

"The three monster engines telescoped with the impact, and when they came to a standstill they resembled one huge piece of twisted iron and steel," said a story on the front page of The Daily Sentinel the next day.

The article added gruesome details: "Eight of the passengers in the chair car were decapitated as though by a guillotine," it said. "The bodies of the dead are so mutilated that it will require many hours to effect their identification.'

Several Grand Junction residents were among the passengers, the paper reported, but all of them apparently survived.

The wreck wasn't the worst in Colorado's history. That occurred five years earlier near Pueblo, when almost 100 people were killed in a collision at Eden, Colorado. Still, the Dotsero collision was among the deadliest in the state's history.

It prompted Engineer Gustav Olson and his family to move from Colorado to California to recover from his injuries and escape the animosity he faced here. Olson was deemed responsible for the wreck, but no criminal charges were filed against him. And he never publicly stated his version of what occurred on that cold night.

Train No. 5 was the westbound passenger train piloted by Olson. It included a steam locomotive, a coal car, baggage car, smoking car, chair car with seats facing each other, a number of Pullman sleeper cars and a dining car. It carried approximately 75 passengers, plus crew

Train No. 66 was a freight

train headed east out of Glenwood Springs, with two locomotives pulling it. W.H. Jeffries was the engineer, and he died later of injuries he suffered in the

When Train No. 5 reached Wolcott on its westbound journey, the crew received a directive from a railroad dispatcher. Olson was to pull the passenger train onto a siding at Dotsero and wait there until 9:55 p.m., allowing the eastbound freight, Train

No. 66, to pass. A second directive ordered him to pull over at Gypsum and allow another freight to pass, but that directive was out of sequence, and may have created additional confusion.

When it reached Dotsero, Train No. 5 continued on. "Without stopping at Dotsero, or diminishing the speed of the train ... and collided with No. 66" at 9:47 p.m., a quarter mile west of Dotsero, said a report by the Colorado State Railroad

Commission. Twenty-one people were killed immediately and 35 were injured. Five of the injured died within a week of the accident. A number of crewmen jumped from both trains just before the collision.


Surviving passengers in the sleeping and dining cars immediately tried to help the injured and dying. Bodies were laid out in the snow. A doctor on board set up a makeshift hospital in the dining car, and treated injured as best he could.

A coroner's jury, empaneled in Redcliff, Colo., ten days after the collision held Engineer Olson entirely responsible for the wreck, and didn't name Conductor Albert McCurdy.

A Jan. 25, 1909, article in the Sentinel said the jury verdict "held that Engineer Gus Olsen is responsible for the disaster." The article added that "Conductor McCurdy ... while not officially exonerated, was not mentioned in the verdict.'

The State Railroad Commission said both men were to

RAILWAY HORROR **OUT THREE SCORE LIVES**

Denver & Rio Grande Headquarters Admit List of Fatalities Will Exceed 25--Survivors Who Reach Glenwood Say That Fully 70 Are Dead

Denver, Jan. 16 .- Headquarters of the D. & R. G. road here, in a statement issued, say the dead in the Glenwood wreck will exceed 25. It is stated 20 bodies have been recovered. Thirtyfive are known to have been injured.

Glenwood Springs, Colo., Jan. 16 .- Twenty-five are known to be dead and at least 30 injured in the collision last night at Dotsero, between a westbound Denver & Rio Grande passenger and an eastbound freight.

Dotsero is 20 miles away. Wires are down and there are no details. The freight was taking a siding and had almost cleared the main track when the passenger struck it. The chair car was cut in two, and the tourist car was telescoped.

Eighteen bodies have been removed. Nobody in the Pullman was injured. Relief has been sent from here.

It is believed the dead will reach 25 to 50, and 30 are supposed to be buried in the debris. Railroadofficials say responsibility rests on the passenger crew, which was trying to "steal" a siding. Others blame the freight crew, charging they had orders to wait for the passenger

Newspapers around the state, such as the Pueblo Sun, also blared the news of Dotsero wreck. But Pueblo, like a number of other papers, overstated how many people were killed.

blame, in a report it issued at the end of 1911. "The responsibility for this accident rests on the train crew of Train No. 5 of January 15. 1909; Gus Olsen, Engineer, and A. McCurdy, Conductor in charge," the commission report concluded.

McCurdy, unlike Olson, testified at the coroner's inquest. He said he had personally received the order from the dispatcher in Wolcott to have the train wait on the siding at Dotsero.

McCurdy also said Olson was late in blowing the train whistle announcing Train No. 5's approach to Dotsero. When McCurdy realized they were zipping past the Dotsero siding at roughly 40 miles per hour, he ordered the brakeman to set the emergency brake. That slowed Train No. 5 to about 20 mph, McCurdy said, but it was too late to prevent the collision.

Because of a long curve in the rail line west of Dotsero, the crew of the freight train couldn't see the oncoming passenger train until it was too late to halt.

Why didn't Olson stop the train at Dotsero? He refused to tell his side of the story, either before the coroner's jury or in any public forum. That led others to speculate.

Brakeman R.F. Roberts suggested "Olsen may have read his watch wrong, or he may have misread the time on the order."

Later, railroad men who weren't present during the crash said Olson may have fallen asleep at the throttle, just as the train reached Dotsero. "He may have been asleep for only a minute or two, but that was sufficient to cause the accident," said a Denver newspaper.

By late January, Olson was in Grand Junction, preparing to leave for California. He was still recovering from his physical injuries and was nearing a nervous breakdown.

But when he walked in downtown Grand Junction, "He was warmly greeted, because the people here feel he was mistreated in every way in connection with the wreck, and the investigation which held him responsible was simply farcical,' one news article said.

After he left Colorado, Olson there was little mention of him again in news articles.

However, the accident at Dotsero did result in a formal recommendation from the State Railroad Commission to the Colorado Legislature in 1910. The Commission wanted the state to require all railroads to adopt what was known as the signaling block system to prevent head-on collisions.

Under the system, railroad lines

or "blocks," and only one train is allowed to occupy a block

at a time. Consequently, trains were expected to have time

to stop before getting too close to another train on the same set of tracks.

Some railroads in Colorado already utilized the block system prior to 1909 crash, but the D&RG and others weren't among them.

"The strong arm of the law is needed to stimulate those companies which have not taken action or which have made progress so slowly that they are chargeable with neglect of duty in this regard," the Railroad Commission stated.

The D&RG didn't fully adopt the block system until 1927, nearly two decades too late for victims of the Dotsero disaster.
